Visa Guidelines for International Conference

Visa Guidelines

Foreign visitors entering India must have a passport valid for at least 6 months after their date of entry into India, except in the case of nationals of Bhutan and Nepal who need to carry suitable means of identification.

Visa Requirements

Visitors to India should ensure that they are in possession of a valid Indian Visa before they start their journey to India. You are advised to contact the Indian Embassy / High Commission / Consulate in your country in order to obtain an entry visa. Please apply for your visa in good time. Your travel agent may also be able to help you. Nationals and/or passport holders from Afghanistan, Bangladesh, China, Iran, Iraq, Pakistan, Sri Lanka, Sudan, foreigners of Pakistan origin, and Stateless persons are required to provide information to the Ministry in the prescribed format given below, 50 days in advance of the date of travel. This information is to be submitted to the Ministry of External Affairs, which in turn will inform the respective Consulates / High Commissions to issue the visas. On receipt of the information, this ministry refers the details of such participants for security vetting to the security agency concerned. On receipt of a no objection from the security agency, this ministry communicates the security clearance to the concerned Indian Mission abroad for the grant of a conference visa to the participant.

To apply for a Conference Visa one needs to have supporting documents such as the:

- 1. Invitation letter sent by Organisers
- 2. Letter of clearance from The Nodal Ministry
- 3. Letter of clearance from The Ministry of Home Affairs
- 4. Letter of clearance from The Ministry of External Affairs

To obtain the above clearances we need to submit the following details of the delegates to the Ministry of External Affairs at least 50 Days in advance After your successful registration for the International Joint Conference of Asian Conference On Ergonomics and Design 2023 (ACED 2023), HWWE 29023 and BRICSplus HFE 2023 (Before September 2023), you will receive visa assistance form, please ensure that this filled in form should reach us within 2 days upon your successful registration. The Ministry of External Affairs of India has been notified of the conference, and accordingly, the Indian missions in all countries will be in contact with the Ministry of External Affairs.

Requirements, Documents, and Special Considerations

All International Travellers are welcome to India:

a. As an applicant, your passport should have at least six months of validity from the day of arrival to India. Further, the passport should have two blank pages whose use will be affected when you arrive in India and your e-visa has to be stamped on the passport.

- b. Another requirement is that you should have a sufficient amount of money to spend while in India, and a return ticket or onward journey ticket. These will prevent unnecessary extensions of your visit beyond the validity of your e-visa.
- c. You will need to upload a recent colored passport-sized photograph that is not more than 4MB.
- d. Pakistani nationals or international travelers with Pakistani passports are not eligible for the electronic visa and should apply for the normal visa at the Mission of India.
- e. The electronic visa is not given to official or diplomatic passport holders or persons endorsed by their spouses or parent's passport. Even children should have separate passports; the same for each spouse if they are traveling together. International travel document holders are also not eligible for electronic visas.

Important Things to Note

- 1. Before leaving for the airport, ensure that you have carried your valid passport and also a printed e-visa approval letter that was sent to your Email.
- 2. The whole visa application process is **ONLINE**. Computer literacy is thus important. Be careful as you make the online application as there may be fake websites purporting to process the Indian e-visa. Confirm that the website is legit to avoid compromising your privacy or loss of your cash.
- 3. There is no refund should your e-visa application process be rejected. As such, you should be careful as you fill in the form to ensure all the details are correct.
