### Admission Policy for the 'International Students' in MBA/MBA(Operations & Supply Chain Management) Programmes at IIM Mumbai

The MBA degree is a two-year full-time residential post graduate programme for graduates from all disciplines who wish to pursue a career in management. The MBA (Operations & Supply Chain Management) is a two-year full-time residential post graduate programme for graduates with Engineering/Technology or related degrees who wish to pursue career in management. In addition to the sanctioned intake for 2025-27 Batch, an extra 06 seats [supernumerary] in MBA and 04 seats [supernumerary] in MBA(OSCM) programme are reserved for international students. Eligible candidates for these seats include persons who are not an Indian Citizen or a Permanent Residents of India. Foreign nationals including, Person of Indian Origin (PIO) cardholders, Overseas Citizen of India (OCI - Dual citizens) cardholders, Non-Resident of India (NRI)'s are considered under the category of 'International student'.

#### **Eligibility Criteria for MBA:**

An applicant should have a Bachelor's degree or equivalent qualifications (of at least three-year degree duration) with minimum 50% marks or equivalent CGPA/Grades from a recognized university/institute after at least 12 years of school education.

**AND**

A Valid CAT/GRE/GMAT Exam score (administered in test centre). For GMAT, minimum overall score of 700 is required with an Integrated Reasoning (IR) score greater than or equal to 5 (five). For GRE, a minimum score of 310 is required. The current version of GMAT/GRE Exam should have been taken after December 31, 2019. For CAT, a minimum overall percentile score of 85 is required.

#### **Eligibility Criteria for MBA(OSCM):**

An applicant should have an Engineering/Technology degree in any branch (of at least four-year duration) with minimum 50% marks or equivalent CGPA/Grades from a recognized university/institute after at least 12 years of school education.

**OR**

Degree from a recognized university/institute with aggregate 50% marks or equivalent in following disciplines: M.Sc. (Mathematics)/ M. Sc. (Statistics)/Dual Degree (Maths and Computing) Minimum 5 yrs./BS./B. Tech (Economics) Minimum 4 yrs.

**AND**

A Valid CAT/GRE/GMAT Exam score (administered in test centre). For GMAT, minimum overall score of 700, the Integrated Reasoning (IR) score greater than or equal to 5 (five). For GRE, a minimum score of 310 is

required. The current version of GMAT/GRE Exam should have been taken after December 31, 2019. For CAT, a minimum overall percentile score of 85 is required.

**NOTE:** Online GMAT/GRE score (exam taken at home) is not acceptable. The validity of standard test scores will be GRE# 5 Years, and GMAT# 5 Years(# Online GMAT/GRE (Take home) exam scores are not valid. Only test centre based GMAT/GRE scores are valid. The validity of CAT score is one year only. The applicant shall obtain the equivalence of the foreign degree from 'The Association of Indian Universities (AIU) New Delhi'(https://www.aiu.ac.in), while applying to IIM Mumbai.

The applicant needs to submit a separate application for MBA and MBA(OSCM), if interested in more than one programme.

#### **Application Fee:**

A non-refundable application fee of US\$ 200.

#### **Programme Fee for MBA/ MBA (Operations and Supply chain Management):**

The programme fee is US\$ 45,000 for two years.

The fee includes tuition fees, and course material. Hostel room rent will be charged separately. The programme fee does not cover personal expenses such as food, travel, clothes, stationery, laundry etc.

#### **Selection Process for MBA and MBA (Operations and Supply chain Management):**

A nominated committee will review the applications and prepare a shortlist of candidates to be invited for personal interview. An interview invitation does not guarantee admission. Interview invitations will be sent via email. All invited applicants will have the option of interviewing at IIM Mumbai campus or online. Final selection is based on a diverse set of attributes which includes performance in CAT/GRE/GMAT, performance in personal interview, academic credentials, work experience, etc.

The separate merit list of international applicants for each programme shall be prepared based on Inter-Se-Merit of composite score. The composite score will be calculated as follows:

<b>Parameters</b>	<b>Weightage</b>
Normalized score based on CAT/GRE/GMAT Score	60
Personal Interview (PI)	20
Academic Performance & Work Experience Score	20
<b>Total</b>	<b>100</b>

Above mentioned weightages for calculation of composite score are tentative and may vary depending on the applicants data status and institute policy.

#### **Guideline for Essays/Statement of Purpose (SOP):**

The applicants are required to submit Essays/SOP based on the following set of questions:

- What career/role are you planning to pursue and why? (100-150 words)
- How would MBA/MBA(OSCM) from IIM Mumbai help you in achieving your career goals? (100-150 words)
- How do you see yourself contributing to the IIM Mumbai community? (100-150 words)

Please feel free to explain any extenuating circumstances (e.g., significant gaps in work experience, choice of recommenders, or poor academic performance).

Copies of,

1. A valid passport
2. A valid CAT/GMAT/GRE score card
3. Transcripts of all academic credentials (Class 10th, 12th, Bachelor's level, PG, etc.)
4. Legitimate documentary proof of International candidature issued by the concerned authority.
5. Work experience certificate/s (if any)
6. Essay/Statement of Purpose
7. Recommendation letters (02 Nos.)
8. Completed online Application form

IIM Mumbai reserves the right to verify eligibility throughout the admission process and program. Applicants should note that mere fulfilment of minimum eligibility criteria will not ensure shortlisting by IIM Mumbai. IIM Mumbai reserves the right to amend this admissions policy at any point of time if it deems

necessary. The Director-IIM Mumbai shall be the final authority to interpret the admission policy, its applicability, violations, and consequential actions thereof. This admission policy shall be governed by and enforced in accordance with, the laws of India.
