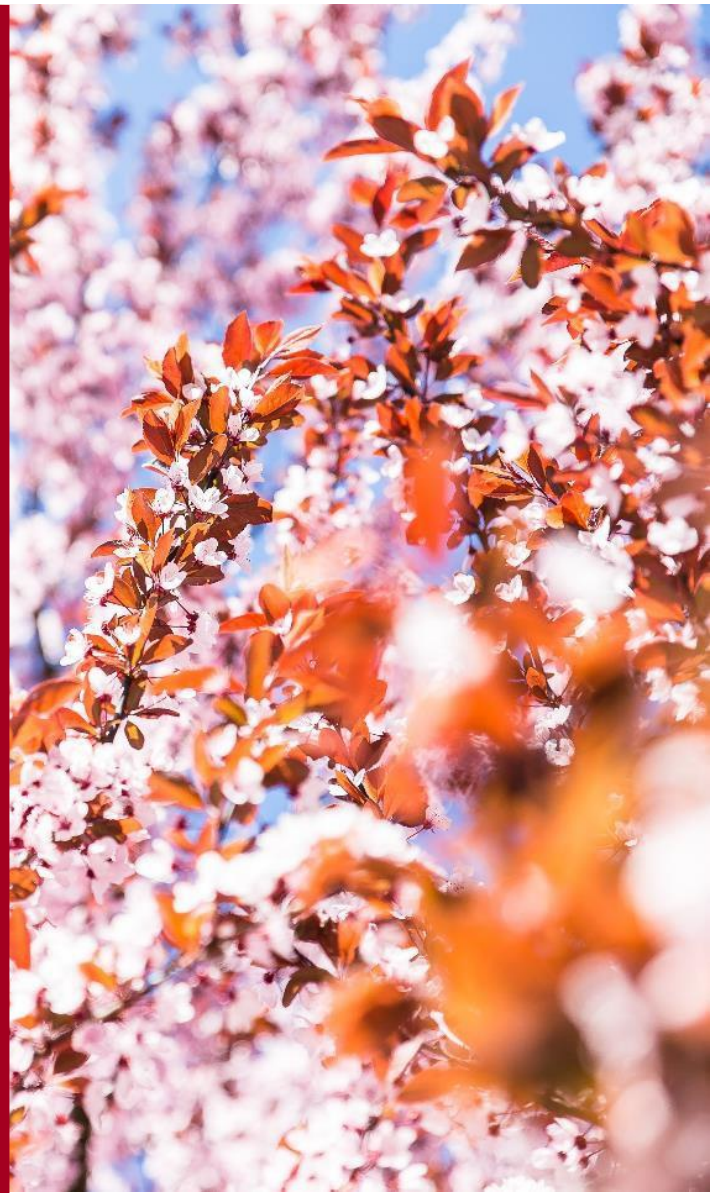

The programme will help **managers & practitioners** to understand sustainability in the language of business and how it can become a value proposition for its diverse pool of stakeholders and create shareholder value.

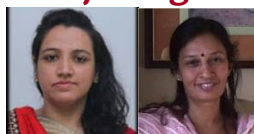
