- In case of admission cancellation after 6<sup>th</sup> June 2022, the entire amount of ₹.1,00,000/- (Rupees One Lakh only) will be forfeited.
- The shortlisted candidates may exercise any of the options (viz, option 1 to option 2).
- In case of withdrawal from the programme after the start of the programme, the candidate who select Option-I will be eligible for the refund of 50% of Caution Money Deposit i.e. ₹.25,000/- (Rupees Twenty Five Thousand) which will be refunded during the 1<sup>st</sup> year (Subject to confirmation full payment of ₹.6,58,000/- (Rupees Seven Lakh Sixty Three Thousand only)

The flexible-fee-remittance module for the SC/ST candidates whose **Annual Family Income** is below ₹4,50,000/- (Rupees Four Lakh Fifty Thousand only) are exempted from paying the **Tuition Fees** of Rs. 3,20,000/- (Rupees Three Lakhs Twenty Thousand only):

The eligible SC/ST candidate who selects Option-I will be eligible for the refund of 50% of Caution Money Deposit i.e. ₹.25,000/- (Rupees Twenty-Five Thousand) which will be refunded during the 1<sup>st</sup> year (Subject to confirmation full payment of ₹.3,38,000/- (Rupees Three Lakh Thirty-Eight Thousand only).
