Indian Institute of Management Mumbai invites applications from interested & eligible candidates for the position of **Site Engineer** purely on contract basis initially for a period of One year extendable further up to Three years subject to satisfactory performance of the incumbent & need of the Institute. KEY RESPONSIBILITIES

- The Site Engineer will be responsible for supervising and managing infrastructure projects at IIM Mumbai. The incumbent will ensure that all construction and maintenance activities are carried out in compliance with safety regulations, quality standards, and project timelines. The key responsibilities include:
- Overseeing the execution of civil, electrical. Plumbing, HVAC & firefighting works for ongoing infrastructure projects.
- Coordinating with contractors, vendors, and project teams for timely completion of tasks.
- Ensuring compliance with government regulations, safety protocols, and environmental guidelines.
- Monitoring site progress and maintaining records of work done, material usage, and costs incurred.
- Conducting site inspections, identifying potential risks, and ensuring corrective actions are taken.
- Liaising with architects, consultants, and institute officials to align construction with project specifications.
- Ensuring adherence to quality control standards and proper execution of contracts.
- Managing workforce, schedules, and materials to optimize project efficiency.
- Preparing and submitting progress reports to the administration on a regular basis.

GENERAL CONDITIONS:

- 1. Mere fulfilling the eligibility criteria does not guarantee that the applicant will be shortlisted for the Interview. The Institute reserves the right to restrict the number of shortlisted candidates for further recruitment process to a reasonable number on the basis of higher qualifications and/or experience.
