Indian Institute of Management Mumbai invites applications for the post of Dean for **IIM Mumbai, Angul Campus at Odisha** with an exceptionally experienced and excellent track record in senior leadership positions from private or government organisations.

**Qualification & Experience**

The applicant shall have distinguished academic record with first class degree in both Bachelor's and Master's level, and with PhD or equivalent from a reputed institutes with at least 15 years of teaching/ research experience, of which at least 5 years should have been as a Full Professor at IIMs/IITs or other peer institutes in India and/ or abroad with high quality publications and Industry connect.

**OR**

The applicant shall have distinguished academic record with first class degree in both Bachelor's and Master's level from a reputed institute with at least 15 years of industry experience in senior managerial positions in reputed organizations in India and/ or abroad.

The applicant must be an Indian citizen or Overseas Citizen of India (OCI).

**Roles & Responsibilities:**

The Dean of campus will be responsible for the overall functioning and management of the IIM Mumbai campus at Angul. The key responsibilities of the Dean of Angul Campus will include strategic planning, academic programming, faculty management, and developing and implementing the strategic vision, ensuring it alignment with IIM Mumbai's overall goals and mission.

Responsible for overseeing the academic programs offered at the Angul campus, including executive education programs for Executives, maintain and improve the quality of education and research conducted at the campus, ensuring it meets the standards of IIM Mumbai and the broader management education community, and other development initiatives of the campus, to manage the campus's budget, facilities, and infrastructure, ensuring effective and optimum utilisation of all facilities and resources to support academic and administrative functions of the campus, as per IIM Mumbai Vision, Mission and core values.

The advertised post is the part of Professor of Practice admissible strength of IIM Mumbai.

The Dean will also act as the representative of the campus, representing the institution to external stakeholders and promoting the campus's programs and research, ensuring the campus's success as a center of excellence in Academics, executive education and research.

**Tenure:** The Dean will be appointed initially for a period of five years on a tenure basis, subject to an annual performance review, for a maximum tenure up to the age of 67 years or five years from the date of appointment, whichever is earlier.
