

Established in 1963 with support from the Indian government, UNDP, and ILO, it is a public business school focused on industrial management, supply chain, and operations. It is ranked 7th among management schools in India according to 2023 NIRF rankings and offers various postgraduate programs, and recently launched a new undergraduate program in digital sciences and business management.

Located in the Financial Capital of the country, IIM Mumbai has close interactions with the leading corporate houses, giving it the added advantage of integrating classroom knowledge with relevant practical inputs from industry professionals. #### Other Initiatives of the Institute

**i.Enactus Projects:** The student chapter of Enactus undertakes various projects for social upliftment. Their current project, "Project Chatr," aims to empower 81 tribal families in KhambachaPada by providing training and market linkage for mushroom cultivation to ensure a consistent source of income during the non-monsoon season.

**ii.Sparsha:** This CSR initiative, part of the annual business summit Lakshya, promotes project work by NGOs and corporations for social upliftment.

iii.CSR Conclave: The student committee for CSR, "Ehsaas," organizes an annual CSR Conclave as part of the management festival "Prerana" where teams design socially impactful policies for firms.

**iv.Toycathon 2021 Grand Finale:** IIM Mumbai (formerly NITIE) hosted the grand finale of Toycathon 2021, a government initiative to promote innovation among students, which included displaying top ideas from across the country.



**v.SNEHA Initiative:** In January 2021, student volunteers organized a relief drive for Gandhibhavan International Trust. They provided essentials like rice, clothes, and other supplies, and spent time with the residents, adhering to COVID-19 safety protocols.

vi.Unnat Bharat Abhiyan initiative: As a part of this initiative, Institute announced the adoption of five villages in Murbad Taluka, Thane District on the 17th January 2020. Our reached remote villages in Murbad Taluka of Thane district to help the villagers in the difficult times of COVID-19. The threefold purpose are:

- 1. Providing support for basic livelihood by distributing grocery items.
- 2. Providing healthcare support through distribution of medical kits.
- 3. Extending earning opportunities utilizing villagers' skills by procuring their products

vii.Alumni Supported Initiatives: Under this initiative, Institute has received a generous contribution from our esteemed alumnus, Mr. Sanat Chattopadhyay, Executive Vice President and President of Merck Manufacturing Division. His substantial donation has been instrumental in supporting our initiatives.
