TERMS AND CONDITIONS

Annual Maintenance and Service Contract for Window, Split, Cassette Air Conditioners, Water Coolers and Water Dispensers

- 01. All the machines will be in working condition at the time of commencement of contract. The contractor will have to hand over all the machines in working condition at the time of completion of contract.
- 02. All the machines should be serviced once in every month.(BDS once in 3 months)
- 03. This contract includes repair and replacement of all controls, compressors, fan motors including gas charging excluding sheet metal work. The compressor which are in original condition will have to be replaced with new compressors of same make when they fail, the cut compressors can be got repaired.
- 04. On breakdown of any machine, call should be attended immediately on the same day failing which Rs. 300/- will be deducted from the bill for each defaulted day.
- 05. If the air-conditioner is taken out for major repairs service unit should be provided in place of existing unit failing which Rs. 500/- will be deducted from the bill for each defaulted day.
- 06. The contractor has to deploy 2 technicians and 2 helpers on regular basis for the servicing and attending breakdown of machines. The technicians and helpers should wear uniform arranged by the contractor and should carry ID without which they will not be allowed within the premises of IIM Mumbai.
- 07. Penalty of Rs 300/- will be levied on technicians/helpers per day per person if they fail to report to work.
- 08. On acceptance of the rates quoted by the contractor, the contractor will be allowed to start the work only after producing the receipt of the security deposit @ 10% of the cost of maintenance and service contract.
- 09.If the Contractor fails to honour the work order EMD will be forfeited.
- 10. The payment will be made quarterly only after satisfactory completion of three monthly services.
- 11.If the contractor shall make default in any one or more of the following respects that is to say :
 - a. If the contractor without reasonable cause wholly suspends the carrying out of work before completion thereof or
 - b. If the contractor fails to proceed regularly or diligently with the work or
 - c. If the contractor refuses or persistently neglects to comply with the written notice from IIM Mumbai asking him to remove defective work or improper material or goods, the Director IIM Mumbai, has the right to terminate the contract immediately.

Director, IIM Mumbai will be the sole authority to take the decision.
