TERMS & CONDITIONS OF SALE

A. The sale is strictly on “AS IS WHERE IS and WHATEVER IS” basis. No claims regarding quality, quantity, or condition will be accepted.

B. Bidders must inspect the lots on 10 & 11 Feb 2026 (11:00 AM – 1:00 PM) at SRIC Building, IIM Mumbai. No dispute will be entertained after bid submission.

C. A Bid Security of Rs. 25,000/- is mandatory. It will be forfeited if:

- the bidder withdraws the bid,
- fails to pay after award, or
- fails to lift the awarded lot.

D. The Highest Bidder (H1) will be recommended for award subject to approval of the Competent Authority.

E. Bid Security must be deposited only through NEFT/RTGS. No FDR/DD/cash/cheque is permitted.

F. The successful bidder must deposit the full quoted amount within 7 working days of issue of the award letter.

G. GST shall be charged by IIM Mumbai as per applicable rate on the date of invoicing. GST registration is NOT mandatory for bidders; unregistered bidders may participate, but cannot claim input credit.

H. After full payment, the bidder must lift the entire lot within 20 working days. Partial lifting is not allowed.

I. Delay in lifting will attract Rs. 1,000/- + GST per day per lot. Continued delay may result in cancellation and forfeiture.

J. All labour, tools, transportation, and loading/unloading arrangements will be entirely at the bidder’s cost and risk.

K. The bidder is responsible for any damage caused to Institute property during lifting and must make good the same at their cost.

L. Bidders and their labour must follow all safety, security, and entry rules of IIM Mumbai.

M. Electricity or water may be provided at a nearby point subject to availability; the Institute will not provide any manpower or tools.

N. Only bids submitted online through CPPP will be considered. Offline/email/physical bids will not be accepted.

3. Firm Registration / Proprietor Declaration
4. GST Certificate (For registered buyer)

P. The Competent Authority's decision regarding award, rejection, or interpretation of the tender is final and binding.

R. Sale once awarded cannot be cancelled by the bidder; any attempt will lead to forfeiture of Bid Security.

S. IIM Mumbai reserves the right to add/remove/modify items in the lot before award, if required. **IIM Mumbai reserves the right to award the sale lot-wise or item-wise based on the individual item rates quoted.**
The bidder shall be bound by such bifurcation and cannot withdraw by claiming that the quotation was given for all items collectively.

T. The Institute may accept or reject any or all bids without assigning reasons.

U. If items fall under e-waste category, the bidder shall comply with CPCB/SPCB norms at their own cost.
